#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 35.00 crore bank facilities of Technology Frontiers (India) Private Limited (TFIPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Chennai-based, Technology Frontiers (India) Private Limited (TFIPL) was incorporated in the year 1996.
