Acuite has reviewed long-term rating of '**Acuite BB-**' (read as **Acuite BB minus**) and short term rating of '**Acuite A4+**' (read as '**Acuite A four plus**') on the Rs. 20.00 crore bank facilities of Suryodaya Infra Projects (I) Private Limited. This rating is now an indicative rating and is based on best available information

The Hyderabad-based Suryodaya Infra Projects (I) Private Limited (Suryodaya Infra Projects), a civil construction company, was incorporated in 2008. The company is engaged in the construction of roads and industrial structures and is managed by Mr. Rajendra Prasada Rao Bezawada, Managing Director and Directors, Ms. Sailaja Bezawada and Mr. Venu Gopala Ramakrishna Vattla. For FY2014-15, the company reported profit after tax (PAT) of Rs.0.96 cr on operating income of Rs.20.49 cr as compared with PAT of Rs.0.94 cr on operating income of Rs.20.13 cr for FY2013-14. The networth stood at Rs.14.57 cr as on 31 March, 2015 as compared to Rs.13.63 cr in the previous year.

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
