Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs.14.00 crore bank facilities of S D Solvex Private Limited (SDSPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Punjab-based, S D Solvex Private Limited (SDSPL) was incorporated in 2013 by Mr. Pardeep Kumar and Mr. Rakesh Kumar. The company is engaged in the extraction of crude, rice bran oil and deoiled cake and has installed capacity of ~300 tonnes per day. The company procures raw material i.e. Paddy and rice bran from local mandis and farmers and sells its product, i.e. rice bran oil to refineries in Punjab and Haryana.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
