Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs.6.60 crore bank facilities of Future Flex Private Limited (FFPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Incorporated in 2011, FFPL is involved in the manufacturing and selling of stitched and unstitched polypropylene fabrics. The management, which includes Shri Ram Bansal, Mr. Vinod Bansal and others, have an experience of more than one and a half-decade in the packaging industry. The manufacturing facilities located at Kaithal (Haryana) have an installed capacity of 8 tons per day.

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
