**Rating Rationale**

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 6.60 Crore bank facilities of Future Flex Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

**About the Company**

Delhi based, Future Flex Private Limited was incorporated in 2011. It is involved in the manufacturing and selling of stitched and unstitched polypropylene fabrics. Mr. Parveen Bansal, Mr. Rakesh Bansal, Mr. Vinod Bansal are directors of the company. The manufacturing facilities located at Kaithal (Haryana) have an installed capacity of 8 tons per day.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

**Limitation regarding information availability**
