Acuité has downgraded the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) and review the short term rating to '**ACUITE A4**' (read as **ACUITE A4**) on the Rs.30.00 crore bank facilities of Powertech Engineers. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Powertech Engineers, established in 2004, is engaged in the installation of electric substations, electric lines, transmission towers and meters. The operations are currently limited to Uttar Pradesh and Bihar.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
