Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-’** (read as **ACUITE B minus**) on the Rs. 9.50 crore bank facilities of Lakshmee Cashews (LC). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on best available information.

About the Company

Lakshmee Cashews (LC) was established in 2006 under the partnership of Mrs. Shradha Nayak, Mr. Kamlashishanai and Mr. Nagraj Kamath. However, in FY2014, Mr. Kamlashishanai and Mr. Nagraj Kamath retired, and Mr. Mahesh Nayak, Mrs. Rashmitha Kamath and Mr. Ratnakar Nayak joined in as new partners. The firm is engaged in the processing of cashew kernels and trading of raw cashew nuts. The unit is located in Udipi, Karnataka with processing capacity of around 50 bags of 80 kgs per day.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to

gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity. Sometimes this non co-operation by a rated entity
