Rating Rationale

Acuité has downgraded its long-term rating of S R Overseas Panipat to **'ACUITE B+' (read as ACUITE B plus)** from **'ACUITE BB-' (read as ACUITE double B minus)**. This rating is now an indicative rating and is downgraded on account of information risk.

S R Overseas (SRO), established in 2014, is a Panipat-based partnership firm engaged in manufacturing of blankets with an installed capacity of 2 lakh blankets per month. The firm is promoted by Mr. Balraj Singh, Mr. Vijender Singh, Mr. Sumit Dahiya and Mr. Rahul having equal profit sharing ratio.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
