Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.8.76 crore bank facilities of S R Overseas (Panipat). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

S R Overseas (Panipat), established in 2014, is a Panipat-based partnership firm engaged in manufacturing of blankets with an installed capacity of 2 lakh blankets per month. The firm is promoted by Mr. Balraj Singh, Mr. Vijender Singh, Mr. Sumit Dahiya and Mr. Rahul having equal profit sharing ratio.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
