Acuité has reviewed the long-term rating of '**ACUITE BB-**' (**read as ACUITE double B minus**) and short-term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs.69.68 crore bank facilities of Komos Automotive India Private Limited (KAPL). This rating is now an indicative rating and is based on best available information.

Komos Automotive India Private Limited (KAPL), incorporated in 2006, is a wholly-owned subsidiary of Komos Co. Ltd., Korea. KAPL is a Tier-I supplier for Hyundai Motors India Limited (HMIL), engaged in manufacturing of steering wheels, horn covers, consoles and trim, pillar parts and clutch assembly for i10, i20, EON, Verna, Elantra models of HMIL.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
