Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B Plus**) and reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 12.00 crore bank facilities of Coastal Chip Boards And Lams Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Established in 2011, Coastal Chip Boards And Lams Private Limited is engaged in the manufacturing of wooden products, cork, straw and other material used for interior designing and decoration. Mr. Nazim, Mr. Naushad Abdul Khader, Mr. Prasanth Malemannisseril Anandan, Mr. Anil Kumar and Mr. Shajeed Abdul Khader are the whole-time directors of the company. The registered office of the company is in Mangalore, Karnataka.

Non-cooperation by the issuer/borrower:
