**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B' (read as ACUITE B)**' on the Rs. 25.00 crore bank facilities of P P Savani Knowledge City. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

PPSKC, established in the year 2016, is a part of P P Savani Education Trust that was established in the year 1987 by Mr. Vallabhbhai P. Savani. P P Savani Education Trust operates 10 schools having total student strength of around 45,000. PPSKC is led by Dr. Sanghani CEO and offers courses such as Physiotherapy, Interior Designing and Biotechnology. The courses provided by the institute are affiliated to Veer Narmad South University, Gujarat.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
