Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 5.00 crore bank facilities of Huns Digital Homes Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Maharashtra-based, Huns Digital Homes Private Limited (HDHPL) was incorporated in 2002 by Mr. Pravin Ranka, Mr. Mahendra Ranka and Mr. Ashok Ranka. The company is a distributor of Panasonic and Philips home appliances such as LED TV's, Air Condition, Refrigerators, Washing Machines, etc. HDHPL is also engaged in trading of electronic products and home appliances for other brands in Pune location.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
