Rating Rationale

Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 10.00 crore bank facilities of Pharmachem Traders Private Limited (PTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Pharmachem Traders Private Limited (PTPL), incorporated in 2000, is a Kolkata-based company promoted by Mr. Sachin Pal PTPL is engaged in trading of various chemicals such as melamine, caustic soda flakes, LLDPE etc. For FY2014-15, PTPL reported profit after tax (PAT) of Rs. 0.03 crore on operating income of Rs.23.98 crore, as compared with PAT of Rs.0.06 crore on operating income of Rs.24.35 crore in FY 2013-14.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. This rating continues to be flagged as "Issuer notcooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
