Acuité has reviewed long-term rating of 'ACUITE BB+' (read as ACUITE double B plus) and short-term rating of 'ACUITE A4+' (read as ACUITE A four plus) on the Rs. 24.75 crore bank facilities of Symbiosis Pharmaceuticals Private Limited (SPPL). This rating is now an indicative rating and is based on best available information.

Symbiosis Pharmaceuticals Private Limited (SPPL) was incorporated in the year 2003 by Mr. V.D Gupta and Mr. Jagbir Singh. The company is engaged in the manufacturer of allopathic medicines in various forms like Soft gelatine, tablets, tubes, drops, Liquid Syrup, Ointment and Injectable etc.
