Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs.6.00 crore bank facilities of V P Bedekar and Sons Private Limited (VPBSPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Maharashtra based, V P Bedekar And Sons Private Limited was incorporated in 1943 by Mr. Annasaheb Bedekar. Currently, the company is headed by the fourth generation of the family viz. Mr. Atul V. Bedekar, Mr. Ajit V. Bedekar Mr. Vasant V Bedekar and Mr. Mandar T Bedekar. The company is engaged in the business of manufacturing spices, pickles, namkeen and other ready to eat food items under the brand name of 'BEDEKAR'.
