Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 5.00 crore bank facilities of Theme Music Company Private Limited (TMC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Theme Music company Private Limited, incorporated in 2008, is engaged in the trading of musical instruments and music books. The company has its presence across the country in Delhi, Bangalore, Mumbai and Goa. It was promoted by Mr. Bhupendra Chaturvedi and Mr. Rajendra Chaturvedi in 2008. The promoters possess over two decades of experience in the trading of musical instruments.

Non-cooperation by the issuer/borrower:
