Rating Rationale

Acuite has reaffirmed the long-term rating to '**ACUITE B+**' (read as **ACUITE single B plus**) and the short-term rating to '**ACUITE A4**' (read as **ACUITE A four**)' on the Rs. 8.30 crore bank facilities of Arvind And Rajan Constructions. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 2009-Arvind and Rajan Constructions (ARC) is a Bangalore based proprietorship firm headed by Mr. Arvind Gopalakrishnan engaged in the business of construction of residential and commercial building works including civil, sanitary and electrical work.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
