Rating Rationale

Acuité has reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 7.11 crore bank facilities of Cititech Township Private Limited. The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
