Acuite has reviewed the long term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 5.43 crore bank facilities of Fatwheels Biker Village Private Limited (FBVPL). This rating is now an indicative rating and is based on best available information.

FBVPL is a Coimbatore (Tamil Nadu) based company incorporated in 2015 and is a dealer and service provider for two wheeler high end bikes and sale of bike accessories. The operations have started from July 2017.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
