Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short-term rating to '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 5.43 crore bank facilities of Fatwheels Biker Village Private Limited (FBVPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Fatwheels Biker Village Private Limited (FBVPL) is a Coimbatore (Tamil Nadu) based company incorporated in 2015 and is a dealer and service provider for two wheeler high end bikes and sale of bike accessories. The company is promoted by Mr. Thampu John, who possess more than two decades of experience in two wheeler industry including operation and sales.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
