Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 10.00 crore bank facilities of B Ghose And Co Private Limited (BGPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

B Ghose And CO Private Limited (BGPL) was established in 1956 as a proprietorship firm, which was later reconstituted as a private limited company in 1970. B Ghose And CO Private Limited (BGPL) is primarily engaged in stevedoring activities apart from being one of the largest handler of breakbulk cargo. The operations are mainly confined to Kolkata port with minor activities in Haldia port. Currently, the business is managed by Mr. Sharad Varma and Mrs. Mallika Varma.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
