Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B' (read as ACUITE B)** from '**ACUITE B+ (read as ACUITE B plus)**' on the Rs. 5.00 crore bank facilities of Oswal Psyllium Exports on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Madhya Pradesh based, Oswal Psyllium Exports was incorporated in the year 2007 and the commercial operations started from 2008 by Mr. Anil Nahata and Mr. Sanjay Begani. The firm is engaged in the business of manufacture and export of Psyllium husk and Psyllium husk powder to various countries such as Pakistan, Afghanistan, USA and others. Oswal Psyllium Export is also engaged in trading of soya beans, mustard oil and wheat, among others to the various client all over India.
