Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 9.40 crore bank facilities of Rourkela Steel Corporation (RSC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Rourkela Steel Corporation (RSC) was established in the year 1974, which trades in iron and steel products and is located in the north-western tip of Odisha. Group's operations are managed by Mr. Kedar Kheria and his son, Mr. Mayur Kheria.

About the Group

Shree Samtainath Enterprises Private Limited (SSEPL) was established in the year 1997 and it trades in iron and steel products and also fabricates them. The company is a part of Shree Samtainath Group, with other major company being Rourkela Steel Corporation (RSC). The West Bengal based company is promoted by Mayur Kheria and Kedar Nath Kheria.
