Acuite has reviewed the long term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs. 8.31 crore bank facilities of Snowbird Marketing Private Limited (SMPL). This rating is now an indicative rating and is based on best available information.

The New Delhi based Snowbird Marketing Private Limited (erstwhile Freebird Marketing Private Limited) was incorporated in 2008. Headed by Mr. Jain and Family, the company is engaged in the business of trading of fabric mainly curtains and sofa. The company procures and sells the fabric in North India. Mr. Vishal Jain (Director) oversees the daily operations of the company.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
