Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs.10.75 crore bank facilities of Sri Seetarama Agro Industries (SSAI). This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower: Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

About the Rated Entity:

Sri Seetarama Agro Industries (SSAI), established in 2009, is a Karnataka-based partnership firm, promoted by Mr. K.V.V.S Prasad, Mr. K.V. Ramakrishna and Mr. K. Adinarayan Rao. The firm is engaged in the milling of paddy and processing of parboiled rice and has installed capacity of 168 MTPD (metric tonne per day).

For FY2015-16, the firm reported net profit after tax (NPAT) of Rs.0.45 crore on total operating income of Rs.58.28 crore as compared with NPAT of Rs.0.63 crore on total operating income of Rs.56.12 crore in FY2014-15. The net worth stood at Rs.8.09 crore as on March 31, 2016 as compared to Rs.7.69 crore as on March 31, 2015.
