### Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.10.75 crore bank facilities of Sri Seetarama Agro Industries on account of information risk. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

### About the Company

Sri Seetarama Agro Industries was established in 2009. It is a Karnataka-based partnership firm, promoted by Mr. K.V.V.S Prasad, Mr. K.V. Ramakrishna and Mr. K. Adinarayan Rao. The firm is engaged in the milling of paddy and processing of parboiled rice and has installed capacity of 168 MTPD (metric tonne per day).

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
