Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B Plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A Four**) on the Rs. 17.00 crore bank facilities of Sree Venkateswara Road Constructions Private Limited (SVRCPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

SVRCPL was established as a proprietorship concern in 1990 at Tamil Nadu and converted to a private limited company in 2008. The company is engaged in the construction of roads, compound walls, drainages, among others. The company is led by Mr. Vedachalam Venkatesan, Mr. Selvaraj Gowri, Mr. Sampath Krishnan.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
