Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short-term rating to '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 8.10 crore bank facilities of Phoenix Engineering (PE). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Phoenix Engineering (PE), established in 1984, is a Nagpur-based partnership firm engaged in civil construction. The firm is a Class 'A' contractor promoted by Ms. Prema Patil and Mr. Sunil Patil. PE undertakes construction for government bodies such as Nagpur Municipal Corporation, National Highway Division (Nagpur) apart from fabrication contracts.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower).
