## Rating Rationale

Acuité has reaffirmed the long term rating of '**ACUITE B**' (read as ACUITE B) on the Rs. 14.00 crore bank facilities of Maks Energy Solution India Private Limited (MESI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## **About the Company**

Maks Energy Solution India Private Limited (MESI), incorporated in 2010, is a Pune-based company engaged in the manufacturing and trading of generators. Promoted by Mr. Saurabh Shaw, the company is also into servicing and selling of spare parts. The company promoted by Mr. Saurabh Shaw and family.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
