Incorporated in 2011, Subrata Kundu Construction Company Private Limited (SKPL) is promoted by Mr. Subrata Kundu and is involved in construction of roads, bridges, government buildings and other civil construction works by bidding contracts from government departments. It carries out construction works mainly in the state of West Bengal.
