Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs. 90.00 crore bank facilities of Sri Parameswara Poultry Farm Private Limited. The rating continues to be flagged as “Issuer Not Co-operating” and is based on the best available information.

Sri Parameswara Poultry Farm Private Limited (SPPFPL) was established in 2011 by Mr. B Shiva Babu and family. The company is engaged in the production of eggs at Shadnagar, Telangana.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
