Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B plus) on the Rs. 24.00 crore bank facilities of Neosa Electronics Private Limited (NEPL). This rating continues to be flagged as "issuer not co-operating" and is based on best available information.

About the Company

Neosa Electronics Private Limited (NEPL) Established in 1986 and located in Kolkata, promoted by Mr. Balaram Chowdhury and Mr Ram Krishna Saha, is a distributor of consumer durables

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
