Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 24.00 crore bank facilities of Neosa Electronics Private Limited (NEPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Neosa Electronics Private Limited (NEPL) Established in 1986 and located in Kolkata, promoted by Mr. Balaram Chowdhury and Mr Ram Krishna Saha, is a distributor of consumer durables.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for
