Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 6.50 crore bank facilities of Rarewala Steels and Alloys Private Limited (RSAPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 2010, Rarewala Steels and Alloys Private Limited (RSAPL), part of the Rarewala Group, is engaged in the fabrication of bright bars, ground bars and peeled bars and caters to the automobile and precision engineering industries. The manufacturing facility is located at Dabaspeth, Bangalore and has an installed capacity of about 10,000 tons per annum. The day to day operations are managed by Mrs. Renu Murarka, Mrs. Pratheechi Murarka, Mrs. Prachi Deora, Mr. Pramod Murarka and Mr. Piyush Deora.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
