#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE BB-' (read as ACUITE double B minus)from 'ACUITE BB' (read as ACUITE double Ba)nd the short term rating to 'ACUITE A4' (read as ACUITE A four) from 'ACUITE A4+' (read as ACUITE A four plus)on the Rs.62.00 crore bank facilities of K G N Electricals (KGNE) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

K G N Electricals, a Karnataka based partnership firm was established in 1997. The partners of the firm are Mr. Mohammed Idress and Mr. Mohamed Younus. The partnership firm is registered EPC contractor for erection and maintenance substations and transmission lines. KGNE, has Super Grade License and caters to government departments in Karnataka.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
