Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 5.70 crore bank facilities of Chordia Industries (CI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Chordia Industries, established in 2001, is a Nagpur-based firm promoted by Mr. Sohel Amin and Ms. Maria Amin. The firm is engaged in ginning and pressing of cotton and also sells cotton seeds and oil. Erstwhile, the firm was promoted by Mr. Chordia and family, but in July 2015 it was taken over by Mr. Sohel Amin and Ms. Marya Amin. The firm's manufacturing unit located at Nagpur, Maharashtra has 48 ginning machines and a pressing machine with the capacity to produce 250 cotton bales per day.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavoured to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit

rating is based.
