Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus)from 'ACUITE BB-' (read as ACUITE double B minus)on the Rs. 5.34 crore bank facilities of Emco Dynatorq Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Emco Dynatorq Private Limited (EDPL), incorporated in 1991, is a Mumbai-based company engaged in the manufacturing of industrial brakes, clutches and other components. The company, promoted by Mr. Dhiren C. Gandhi, Mr. Chandrakant Gandhi and Mr. Sandip Gandhi, has four manufacturing units, two at Vasai near Mumbai and two at Baroda, Gujarat with a manufacturing capacity of 60,000 units per annum.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
