### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus)from 'ACUITE B' (read as ACUITE B) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 6.70 crore bank facilities of Linear Enterprises (LE) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

Linear Enterprises (LE), established in 1991, is an Aurangabad-based proprietorship concern engaged in the repair and maintenance of switchgears and other machinery parts. The firm undertakes contracts (installation, repairing, servicing, commissioning and erection testing) on turnkey basis. Promoted by Mrs. Manisha Panchakshari, Linear Enterprises also trades in isolators, rectifiers, transformers, switch gears, on load tap changers, etc.

#### **Unsupported Rating**

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance

& review of the rating. However, the issuer/borrower failed to submit such information before the due date.
