Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (**read as ACUITE B plus**) on the Rs. 15.00 crore bank facilities of Lakshmi Ganesh Agro Fertilizers Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Lakshmi Ganesh Agro Fertilizers Private Limited (LGAF), based at Hyderabad, was incorporated in 2011 commenced commercial production in September 2015. The company is engaged in the manufacture of NPK fertilizers under the brand name 'VFL SIMHA'. The company has installed capacity of 1, 20,000 MTPA and produces 400 MT of NPK mixtures per day. Mr. Harsha Reddy Ponguleti and Mr. Ravisankarreddy Ramala are the promoters.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
