## **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 15.00 crore bank facilities of Lakshmi Ganesh Agro Fertilizers Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Lakshmi Ganesh Agro Fertilizers Private Limited, based at Hyderabad, was incorporated in 2011 commenced commercial production in September 2015. The company is engaged in the manufacture of NPK fertilizers under the brand name 'VFL SIMHA'. The company has installed capacity of 1, 20,000 MTPA and produces 400 MT of NPK mixtures per day. Mr. Harsha Reddy Ponguleti and Mr. Ravisankarreddy Ramala are the promotors.
