Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 15.00 crore bank facilities of Vinayaka Agro Fertilizers India Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 2010, Vinayaka Agro Fertilizers India Private Limited is a Nellore (Andhra Pradesh) based company promoted by Mr. R Ravi Shankar Reddy and Mr. P Harsha Reddy. The company is engaged in the manufacturing of single super phosphate (SSP) fertilizer. Facility is located in Nellore (Andhra Pradesh) with an installed capacity of 1.2 lakh tonnes per annum (TPA).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
