**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 6.50 crore bank facilities of V M Maniyar Exports (VMME). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Established in 2011, VMME is a Gujarat-based partnership firm promoted by Mr. Ashok Maniyar and Mrs. Vaishali Maniyar. The firm is engaged in manufacturing of sandalwood chips, flakes, powder and oil in Surat (Gujarat). The firm imports raw material, i.e. sandalwood from Australia and entirely exports its finished product to Dubai and Australia.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
