Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.7.39 Crore bank facilities of Bharat Industries (BI). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Bharat Industries is a partnership firm established in 2010 by Mr. Abhishek Jain and Mrs. Richa Jain as partners. BI is based out of Agra and engaged in the manufacturing of diesel engines, pumps and generator sets.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
