Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus)on the Rs. 9.55 crore bank facilities of Uma Fabrics (UF) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Uma Fabrics, established in June 2012 is a Gujarat-based partnership firm promoted by Mrs. Jyostnaben J. Patel, Mr. Rajendrabhai C. Patel, Mr. Sunny Jaswantbhai Patel and others. The firm is engaged in the business of fabric weaving (processing of yarn to grey fabric) and has a weaving unit at Kalol, Gujarat. The installed capacity is 250,000 meters per month.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
