SMERA has reviewed long-term rating of '**SMERA B-**' (**read as SMERA B minus**) and short term rating of '**SMERA A4**' (**read as 'SMERA A four'**) on the Rs. 7.20 crore bank facilities of Solaroy Engineers Private Limited. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

About the Rated Entity

Incorporated in 1986, Solaroy Engineers Private Limited (SEPL) deals in fire fighting equipments and caters only to government entities. The company imports firefighting equipments from Austria.

For FY2014-15, the company reported profit after tax (PAT) of Rs. 0.02 crore on operating income of Rs. 3.27 crore, as compared with profit after tax (PAT) of Rs.0.07 crore on operating income of Rs. 12.38 crore in FY2013-14. The net worth stood at Rs.0.93 crore as on 31 March, 2015 against Rs.1.16 crore a year earlier.
