Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) and the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 7.20 crore bank facilities of Solaroy Engineers Private Limited (SEPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Mumbai based, Solaroy Engineers Private Limited (SEPL) was incorporated in 1986 by Mr. Aroop Roy and Mrs. Carole L. Roy. The company is engaged in the trading of rescue systems and firefighting equipment along with rendering of services related to the said products. The company imports this firefighting equipment from Austria, U.K., France, and China, to name a few and supplies to Government entities.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
