**Rating Rationale**

Acuite has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE Bf**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) on the Rs. 9.50 crore bank facilities of Praful Exports (PE) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

**About the Company**

Praful Exports (PE) established in 1993 is a partnership firm engaged in the trading and processing of grey fabrics. PE is part of the Surat-based Praful Group engaged in the manufacture of sarees and dress material under the 'Praful' brand name. The firm sells its products in the domestic market as also exports to UAE, Indonesia, China, Malaysia, to name a few. The firm generates around 70 percent revenue from the domestic market with the remaining from overseas. Praful Exports was promoted by Mr. D N Agarwal, Mr. N. Agarwal, Mr. Jai N. Agarwal and Mr. Shiv N. Agarwal. The registered office of the company is in Gujarat.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer

along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
