Rating Rationale

Acuite has reviewed long-term rating of '**ACUITE B' (read as ACUITE Double B)** on the Rs.5.25 crore bank facilities of Mangal Murti Agro. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

ACUITE has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit required documents before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and ACUITE's policies.

Mangal Murti Agro was established in the year 2015 as a Chattisgarh based partnership firm. The company is engaged in processing of non-basmati parboiled rice and has a manufacturing facility at Dhamtari, Chattisgarh with a processing capacity of 80 tonnes per day. The company had started its commercial operations in December 2015.
