**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B-**' (**read as ACUITE B minus**) on the Rs. 6.50 crore bank facilities of Sainath Charitable Trust (SCT). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

SCT was incorporated as a partnership firm on December 11, 2014 by Dr. Ashutosh Yadav, Dr. Dinesh Ram, Dr. Amit Tiwari and Mr. Rajesh Kumar. SCT was setting up a multispecialty hospital at Sonebhadra (Uttar Pradesh).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
